## DESCRIPTION

The property forms part of a block of 4 terraced portal framed units with internal clearance to haunch of 4.89m.

To the front of the unit is a concertina shutter loading door. Internally, there is a concrete floor and WCs.

The unit has 3-phase electricity and an eaves height to the underside of the haunch of some 5.01m. There is high level glazing to all external elevations.

Outside there is a tarmac surfaced car park for 8 tandem parked cars together with a concrete access from Kernan Drive linking with the loading access points.

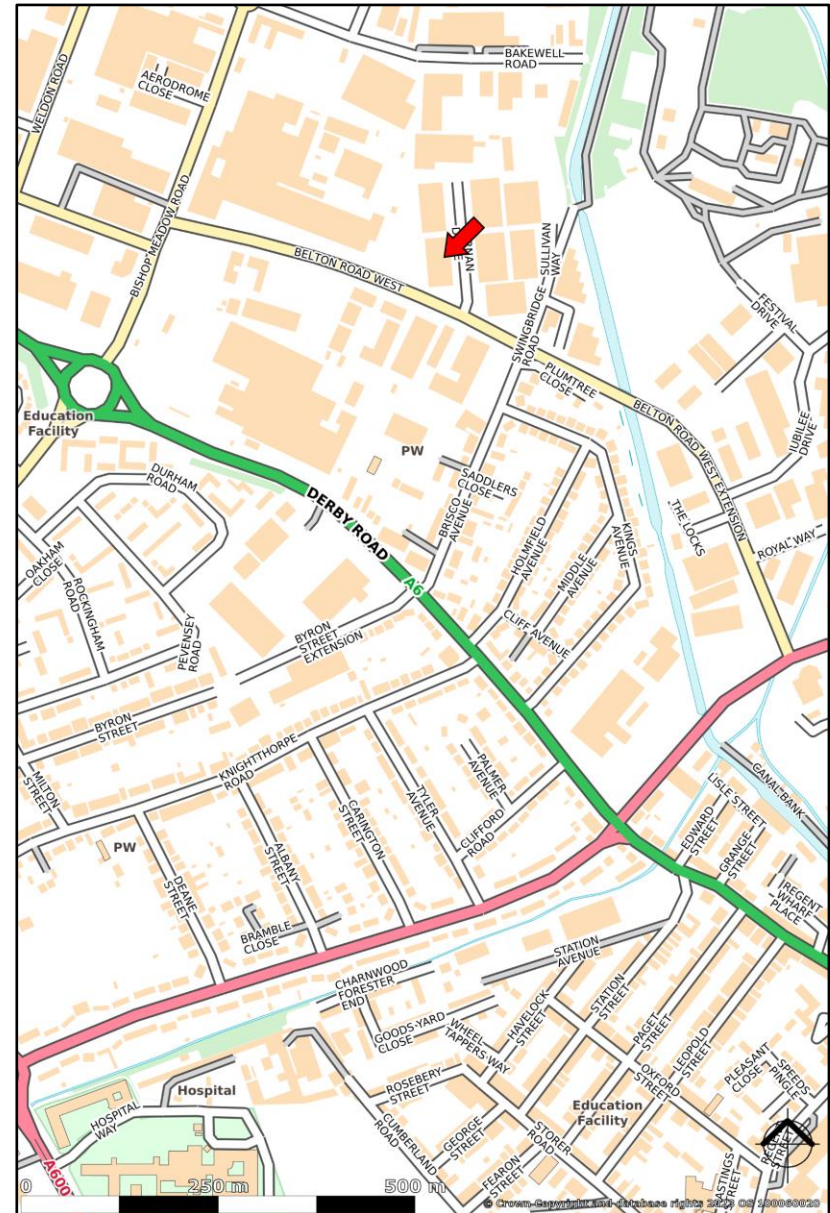
Nearby occupiers include Howdens, Eurocell, SIG Distribution and City Electrical Factors.
